Ride at your own risk.

RELEASE, WAIVER AND INDEMNIFICATION

The undersigned participant and his/her parent or legal guardian (if under the age of 18 years), with full knowledge of the above, does hereby execute this RELEASE, WAIVER AND INDEMNIFICATION for him/her self and his/her heirs, successors, representatives and assigns and hereby agrees and represents as follows:
